GLOBAL MINERALS CLOSES PRIVATE PLACEMENT

Vancouver, B.C., October 1, 2009 – Global Minerals Ltd. (the “Company”) announces that it has closed its private placement previously announced on September 23, 2009. The Company raised \$100,000 through the issuance of 5,000,000 units at a price of \$0.02 per unit. Each unit consists of one common share in the capital of the Company and one share purchase warrant (a “Warrant”). Each Warrant is exercisable to purchase one additional common share over a two-year period, at a price of \$0.05 per share in the first year, and at a price of \$0.10 per share in the second year, expiring September 30, 2011. All securities issued pursuant to the private placement are subject to a four month hold period expiring February 1, 2010. Proceeds of the private placement will be used for general working capital.
